State Deputy's Message



Nevada's Right to Life Team

Worthy Brother Knights,

At this pivotal inflection point in history, we are compelled to assert our unwavering courage. As Catholic men, husbands, fathers, and advocates for the inherent dignity of every human life, we are once again being summoned to defend the "Cor" values of the Order.

A critical referendum vote, Question 6, poses a significant threat to the fundamental moral and legal framework of our state. This proposal advocates for the elimination of parental rights, the expansion of abortion access without stringent limitations and the establishment of procedures that can be performed by a broad range of individuals, not exclusively that of a licensed physician. Essentially, the proponents of Question 6 aim to enshrine an unrestricted and unhindered right to abortion within Nevada's State Constitution, irrespective of the health and safety concerns of minors or teenage girls who may require the professional medical care of licensed physicians.

Supreme Chaplain's Monthly Challenge



Each month, Archbishop William Lori – Supreme Chaplain of the Knights of Columbus – selects a brief passage from the Gospel reading of one of the Sunday Masses of the month. This month we look at Lk 24:35, the reading for April 19.

“Then they told what had happened on the road, and how he was known to them in the breaking of the bread..”

The disciples on the road to Emmaus did not recognize Jesus until the breaking of the bread. Jesus promised he would be with us always, and the Eucharist is his fulfillment of that promise. We encounter his presence most profoundly in the Eucharist, where he is truly present — body, blood, soul, and divinity — under the appearance of bread and wine. The disciples’ experience on the road to Emmaus was no ordinary meal, but an encounter with Christ, who invites us, too, to enter into communion with him through the Eucharist.

Challenge by Supreme Chaplain Archbishop William E. Lori:

This month, I challenge you to remain in prayer and adoration for several minutes after Mass to grow in awareness of Christ’s true presence in the Eucharist.

Questions for Reflection:

Do you fully realize it is the true body and blood of Christ that you receive in the Eucharist? Do you habitually pray in thanksgiving after Communion for this immeasurable gift? Do you consistently participate in Mass on Sundays and holy days? Do you make an effort to attend more frequently, so that you might avail yourself of the graces of this great sacrament?

Lector's Reflection: The Paraclete



We are all faced with a series of great opportunities brilliantly disguised as impossible situations.

A paraclete is one who renders aid. The word appears only five times in the New Testament and only in John's writings (John 14:16, 26; 15:26; 16:7). The Greek word παράκλητος (παράκλητος) is often translated "Helper," "Comforter," "Counselor," or "Advocate." In its most common usage, παράκλητος is a legal term --- Imagine yourself in a courtroom, accused of a crime. Desperate and alone, how will you convince the judge of your innocence? You need a spokesperson, someone to plead your case on your behalf. You need someone to come to your aid. You need a παράκλητος.

In John 14:16 & 26, Jesus promised to send "another Advocate" -- the Holy Spirit -- the Spirit of truth who will be with us forever. He will "teach you all things and bring to your remembrance all that I have said to you."

Do we find ourselves today in need of an advocate, a comforter -- a paraclete? Let's recall Paul's words in Romans 8:26. "Likewise the Spirit helps us in our weakness. For we do not know what to pray for as we ought, but the Spirit himself intercedes for us with groanings too deep for words."

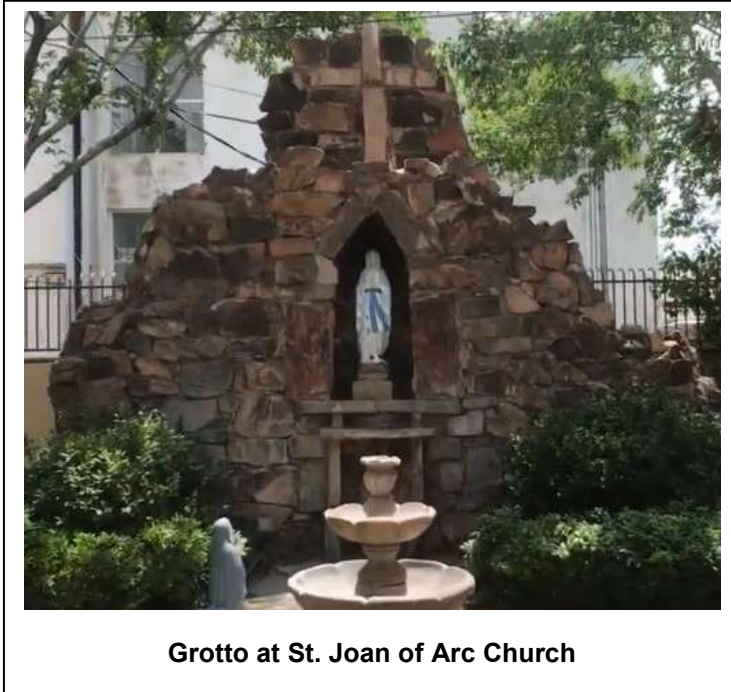

First Catholic Church in Las Vegas



The first Catholic parish established in Las Vegas, Nevada was St. Joan of Arc Catholic Church. Although 1906 is sometimes mistakenly cited, historical documentation consistently identifies 1908 as the official year the parish was organized.

Chronological Development:

- 1905 – Las Vegas was founded as a railroad town. Catholic priests occasionally visited and celebrated Mass in private homes or rented halls before a parish was formally established.
- 1908 – Bishop Lawrence Scanlan formally organized St. Joan of Arc as the first Catholic parish in Las Vegas. Father Edward Reynolds was appointed as the first pastor.
- 1909 – Property was purchased on Second Street (now Casino Center Boulevard) for the construction of a church building.
- 1910 – A small wooden chapel, often referred to as a 'Cottage Chapel,' was completed and became the first dedicated Catholic church building in Las Vegas.
- 1940 – A larger permanent church structure was dedicated as the parish expanded alongside the growing city.

Clarification Regarding the Year 1906: The year 1906 is associated with other Catholic developments in Nevada, including the establishment of Sacred Heart Church in Ely. However, it does not correspond to the founding of the first Catholic parish in Las Vegas. The historically supported founding year for Las Vegas' first parish remains 1908.

I am a cradle Catholic, born and raised near Pittsburgh, PA, the third of four brothers. In public school, I was on the golf team, debate team, and the yearbook editor. I met my wife Midge in high school. She was a pom-pom girl -- beautiful and smart. We started dating, and then I left for the University of Notre Dame. We were engaged in my freshman year, so I transferred to Duquesne University in Pittsburgh. We had a beautiful Catholic wedding, and she and her family helped put me through college.

I graduated in three years and enrolled in Duquesne's Law School. I went to work in a large corporate Legal Department in Pittsburgh and became a tax attorney. Then, thanks to the grace of God and an intense internship in the Gulf Oil Tax Department, I -- like several of my coworkers -- became the head of large corporate tax department.

Midge and I moved to Houston, TX where we had our first son. When Chevron took over Gulf Oil in 1985, we moved back to Pittsburgh where our second son was born. There we had a stable life there for 15 years. During this time, I was a Sunday-only Catholic, although I did help with my eldest son's Boy Scout Troop and I led a successful company charity drive. Then a corporate shakeup sent us to North Carolina, Detroit, and finally to Chicago.

In Chicago in 2011, I had major surgery for a cancerous mass in my pancreas. The night before the surgery -- not knowing if I would survive -- I got down on my knees and promised God

"If you save me from this, I will turn up my faith and serve you." Despite a long and severely painful surgery and recovery, I focused on work and remained a workaholic. When I retired in 2016, and we moved to Las Vegas, I knew I had an I.O.U to pay to the Lord.

I needed to get closer to God, so I joined St. Thomas More Catholic Church in Henderson -- a large parish with a wonderful patron saint for lawyers. I started as a lector, joined two small groups, and five years ago, started a weekly men's faith group.

In 2022, some amazing events changed my life. Joe Haun asked our men's group to form a Knight of Columbus Council. The parish is nearly 40 years old and it had a Men's Club that socialized and raised money, but some of us in the Club wanted more faith. I ended up in the hospital for a tune-up surgery and Stephen, whom I just met in small group, came to my hospital room and prayed for me. Right after I was discharged, Tom Melton asked me and Stephen to become council officers. I said, "I'll serve if you let me work on Life issues." Honestly, I did not plan to say those words. Stephen also said yes. We had no idea what two men saying yes to the Lord would lead to. We got a quick answer.

In the next three months, I went to the first Imago Dei Conference - it's a local Life Conference started by Women's Resource Pregnancy Center (now named Allyfe). I heard a faith reflection, testimonies, and facts about the pro-life battle.

One month later, four people -- myself, Teresa, (a young mom from Church), a security guard and a regular sidewalk witness -- prayed on a sidewalk 100 yards from an infamous abortion center in Las Vegas. It was our first time doing so. We prayed to the Virgin Mary for a full hour. We watched as a car drove by slowly and the driver looked at us. The car parked at the abortion center and a young woman went in. Soon afterward, the woman came out. She was six months pregnant and her name was Dina. She told our group that she decided to save her baby thanks to our prayer.

Our group was overwhelmed. Charles, the big security guard, started crying and told us that he and his wife had had an abortion and split up. He had quit the Knights and the Church. After this miracle, he said he was going back to Church! Three saves in one hour! Stephen and I prayed at that sidewalk, and the abortion center closed (it moved to another location). There is a back story. I almost failed to pray on that sidewalk due to spiritual warfare. I was just interviewed about that and the fight for life. The 36-minute video is available at these links. I recommend it to all the Knights and their families and friends.

CONTENTS - Two parts and time stamps below - 36 minutes total. What did God help Mark do, in 2022, since then, and today? What is he calling ME to do? My interview starts at 12:30 on my call to do pro-Life and what the Knights do for Life. 12:30 - 36:22. Then the call to action on Q6 and IMAGO DEI MOVEMENT, and more. 43:55 - 55:51.

I learned that:

1. Abortion stops one heart and breaks another. And that broken heart grieves, often secretly, for the rest of her life. But women are not the only ones grieving. Men grieve too. If you are carrying abortion trauma, seek help through prayer, God's forgiveness through confession, and consider a healing retreat. Ask for help.
2. My journey since retiring here has been one of discerning what God calls me to do. I did not get an itinerary from God on this journey. It unfolds daily according to His Will. I have heard people say "God does not Call the Qualified. He Qualifies the Called." For me, it is true. Selecting a personal Bible verse set me on a course. "You are the light of the world. ...Just so, your light must shine before others, that they may see your good deeds and glorify your heavenly Father." (Matthew 5:14)
3. I have spent the last three years learning and fighting for Life. Being a Knight has made all the difference. Mainly – encouragement and brotherhood, Fraternity, Charity, Unity. "Where two or more are gathered!" Small groups and friendships have helped me build a strong faith foundation - put God first, run faith formation/COR, learn the Catechism. Then be courageous, stay strong, learn to live your life on both halves of the Penitential Rite. Live the Beatitudes. Serve others. Meet people you would not otherwise meet and you **are** the Knights of Columbus! Build the Kingdom on the shoulders of faithful people like my father and grandfather, and other past Knights and Life Directors.

Life Director Report: Nevada Girls Sports Petition

The U.S. Supreme Court is considering a case dealing with ...laws that concern natural, physical distinctions in the human body. If these state laws are struck down, it would undermine a state's ability to make reasoned arguments and statements about the central distinction present in the human community since the dawn of time: male and female.

A petition drive is an effort to reverse how the Nevada ERA undermines a state's ability to make reasoned arguments and statements about the central distinction present in the human community since the dawn of time: male and female.

The legal significance extends beyond the preservation of logic in single-sex competitions. It involves the ability of states to pass laws based on that logic, which may also apply in other contexts.

- What if all state law efforts that require sex distinction violate the Constitution?
- What if states cannot develop laws that rely on objective, biological criteria to distinguish between men and women when regulating other spaces where those physical differences are, like in sports, the reason for separation?

Talking points to promote the petition to allow voters to decide:

1. Girls deserve a safe, fair playing field today—not years from now.
2. When biological males compete on women's teams, female athletes lose championships, opportunities, and scholarships and suffer serious harms and safety risks.
3. The NCAA amended its participation policies this past February to declare that biological male athletes "may not compete for an NCAA women's team," no matter how they identify.
4. A significant portion of public opinion that supports fairness and safety for women and girls in athletics.
5. The USCCB's advocacy reflects a commitment to ensuring that women and girls can compete safely and fairly in sports, reinforcing the need for policies that respect biological differences.
6. Catholic world News reports "The chairmen of two committees of the US Conference of Catholic Bishops have announced their support of the Protection of Women and Girls in Sports Act of 2023."

Surge of New Converts Have Bishops Puzzled



This Easter the Archdiocese of Detroit received 1,428 new Catholics into the church, its highest number in 21 years. The Archdiocese of Galveston-Houston will have its most in 15 years. In the Diocese of Des Moines, the count is jumping 51 percent from last year, from 265 people to 400.

Bishops are trying to understand what's behind the wave. "Of course we think the Holy Spirit is," Cardinal Robert McElroy of Washington said. "But we are kind of stymied."

His own archdiocese expects 1,755 people enter the church this Easter, up from last year's 1,566, which had already been the highest number in at least 15 years, according to the archdiocese's records.

"In our age of uncertainty, and in our age of great anxiety, is a thirst and hunger for God and stability that faith brings to people's lives," said Archbishop Mitchell Thomas Rozanski of St. Louis, where the reported numbers have not been this high since 2016.

For Jesse Araujo, 19, in Pahrump, the biggest influence in drawing him to the faith was listening to Catholic podcast stars he found on YouTube, like Father Mike Schmitz. He went to Mass only a few times before joining the O.C.I.A. process. He felt an obligation after learning about the sacraments. "I follow Jesus — Jesus left a church, I should follow that church," he said. Now both of his parents are taking O.C.I.A. classes, too, he said, which made him feel a sense of pride.

"Are we prepared to give these new and returning Catholics, especially the men, a way to complete their journey and the invitation to our programs so they can put their new Faith into Action?" asks Regional Growth Director, Chuck Davlin. "How can I help?"

Knights attend Świąconka on Holy Saturday



Świąconka is the Polish tradition of blessing food for Easter. Families prepare baskets filled with symbolic foods such as eggs, bread, and sausage and take them to church on Holy Saturday to be blessed by a priest. This ritual, rooted in early medieval Christian practices, emphasizes the significance of these foods in celebrating Easter and the resurrection of Christ. Six Knights, their families and nearly 60 other people, attended the second annual Blessing of the Easter Baskets conducted by Fr. Dariusz Miskowicz, pastor, at St. Rose of Lima Church on April 4. The Knights knew the blessing was genuine because Fr. Dariusz recited it in Polish. (He later gave an English translation.)

Items included in a typical Easter Basket include:

- Masło (Butter) - The butter is often shaped into a lamb (Baranek Wielkanocny) or a cross. This reminds us of the good will of Christ that we should have towards all things.
- Babka (Easter Bread) - A round or long loaf topped with a cross or a fish, symbolic of Jesus, who is the Bread of Life.
- Chrzan (Horseradish) - Symbolic of the Passion of Christ still in our minds.
- Jajka (Eggs) and Pisanki (decorated with symbols of Easter, of life, of prosperity) - Indicates new life and Christ's Resurrection from the tomb.
- Kielbasa (Sausage) - A sausage product, symbolic of God's favor and generosity.
- Szyńka (Ham) - Symbolic of great joy and abundance. Some prefer lamb or veal. The lamb also reminds Christians that the Risen Christ is the "Lamb of God."
- Sol (Salt) - A necessary element in our physical life. Symbolic of prosperity and justice and to remind us that people are the flavor of the earth.
- Ser (Cheese) - Symbolic of the moderation Christians should have at all times.
- Candle - Represents Christ as the Light of the World.

The basket is usually covered with an elaborately embroidered linen cloth and tied with colorful ribbons as a sign of joy and new life in celebration of the Resurrection. The food is eaten in a traditional meal on Easter Sunday.

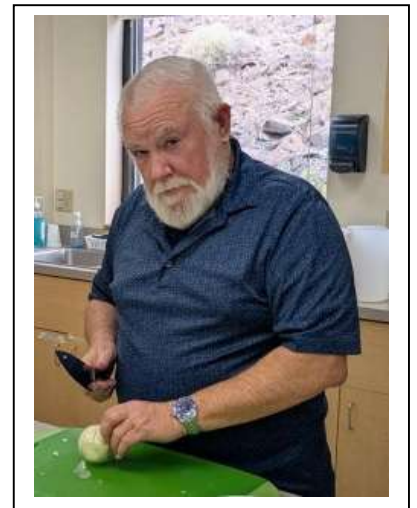

ABOUT THE PETITION

In 2022, voters ratified the State Equal Rights Amendment to the Nevada Constitution. One of the unintended consequences is allowing biological males in female sports, jeopardizing safety, scholarships, a chance to play, and safe locker rooms and showers for Nevada's girls and women. The Protect Women's Sports is attempting to fix this problem – The Protect Girls Sports Petition.

Publicly funded athletic programs must classify sports teams and competitions as one of the following:

- Male
- Female
- Co-ed/Mixed-sex

To protect girls' sports, we must gather 150,000 valid signatures from registered Nevada voters to put this on the November ballot. Your help is needed. You can gather signatures and get us there!

What's more, your efforts can help defeat Question 6 - the radical abortion amendment that will be on the 2026 ballot.


HOW DOES THIS IMPACT NO ON 6 CAMPAIGN?

People who care about girls sports care about making sure underage girls seeking an abortion have a **mom or dad** involved. They are our voters. Getting them engaged in this adjacent effort increases their likelihood of them **voting No on 6**.

RULES - PLEASE READ AND ABIDE BY

The rules we must follow are very strict. Any signature or form that doesn't meet the requirements may be declared invalid. Please read carefully and follow the instructions. Items in red require extra attention.

VOLUNTEER RULES (2 pages)	
1	Petitions must be turned in by June 1 . Don't wait. Send them in weekly.
2	Do Not download, copy, or unstaple packets as this invalidates all signatures on that petition.
3	One Petition packet = one County/ Petition district. Every packet must contain only signatures from the same County/Petition District . All signatures must be from the same county/district.

	CUSTODY AND SIGNATURE RULES - VERY IMPORTANT
6	DO NOT HAND PACKET TO ANOTHER VOLUNTEER. Only one volunteer per packet (Shepherd 1-3 packets at a time during entire event). Best way to do this at an event is have three packets in front of a volunteer to monitor.
7	Do not write - or allow signer to write - stray lines or information anywhere on petition packets.
8	Signers ONLY sign a petition packet for THEIR County/District Number Use Congressional District finder – Go to: ZIP.DefeatSix.com or use. (See provided zip code list for districts)
9	THIS LINE IS BLANK
10	Keep custody of your packets & observe every signature.
11	Do not help a voter fill out boxes.
12	If a signature or other signature information goes outside the box, or there are stray marks, draw a line through the affected box so no one uses it. If writing extends into the “This space for office use only,” strike through and ask the signer to re-sign.
13	Signature volunteers must be 18 or older.

15	Black or blue ink pen only. (No other color ink or pencil). NO WHITEOUT.
16	BLOCK LETTERING is advised.
17	If a signature goes outside the box, draw a line through the affected box so no one uses it.
18	In Address - encourage signer to write city / zip / county (In the city county block)
19	Signers must sign with address the registrar has on file. No P.O. Boxes!
20	Signers must be registered to vote in NV. To check registration or start. Go to: https://registertovote.nv.gov
	It does not matter whether they have ever voted in NV.

	NOTARY AND CERTIFICATION
21	You must have the petition Notarized that you observed every signature on the petition.
22	Once you have completed a packet or it is the end of the week, it is time to get your packet(s) notarized
23	Circulators should attach a post-it note or a <u>note paper clipped</u> to the completed petitions with either phrase: <u>POGPAC</u> – or – <u>NO ON 6 CAMPAIGN</u> . DO NOT WRITE ON PETITION itself.
24	The last page of the packet is the notary page. Do not fill out until you see a notary. You will sign this page in front of the notary affirming that you observed all signatures in the packet.
25	Notaries can be provided, or you can find one at many churches, banks, and attorney’s offices.
